Pursuant to our recent discussions, the Company has entered into an incentive program with its vehicle vendors, Ford and General Motors, to offer incentives for PG&E employees that purchase a new Ford or General Motors Electric Vehicle (EV) between now and the end of 2014. As part of this program, the Company is offering an additional \$2,000.00 (net) incentive for employees to purchase a qualifying electric vehicle.
