Gentlemen:

Company intends to consolidate each manned warehouse in North Bay Division into the new North Bay Distribution Center. The schedule for consolidation will occur between September of 1977 and September of 1978 with various centers phased into the consolidated Distribution Center over this period of time. Included in this consolidation effort will be approximately ten positions in the Emeryville facility, which prior to consolidation, served the North Bay area.

In order to handle the dislocations that result from these changes with a minimum of disruption to Materials Distribution employees, Company proposes to offer positions at the North Bay Distribution Center to all Materials employees in North Bay and to those employees in Emeryville whose positions are transferred to North Bay before filling the positions at the new Center in the normal manner. Company further proposes to maintain the present rate of pay and classification of any North Bay employee or Emeryville employee electing to transfer to the new Distribution Center under the above procedure.

Following the above procedure, Company proposes that the provisions of Title 206 of the Physical Agreement be used to place any remaining displaced employee, with the exception that the displacement of employees under this procedure will be limited to North Bay Division for employees assigned to North Bay Division and to Emeryville for employees displaced within Emeryville, provisions of Subsections 206.4(a) and (b) notwithstanding. Finally, Company further proposes that employees who either transfer to or are displaced as a result of this agreement be extended rights under Section 206.9 of the Physical Agreement to return to their former classification in Emeryville or North Bay Division as the case may be, if such classification is available or reestablished at their former headquarters.

The above approach of the consolidation of North Bay Division and Materials Distribution facilities is consistent with the approach taken in other instances of consolidation and with Company's commitment concerning the maintenance of present classifications for employees.
