The above-subject grievances have been discussed by the Pre-Review Committee prior to their docketing on the agenda of the Review Committee and are being returned, pursuant to Step Five A(1) of the grievance procedure, to the Local Investigating Committee for settlement in accordance with the following:

These cases were all held pending the outcome of Arbitration Case No. 99 which concerned the discharge of an employee for excessive wage garnishments.

Based on the arbitrator's decision, the Pre-Review Committee agrees to settle Case Nos. 766, 781 and Arbitration No. 101 by reinstating the grievants to their former classifications and headquarters following a 30-workday disciplinary layoff. The reinstatements are with service and benefits intact except that their vacations will be adjusted in accordance with Subsections 8.5(a) of the Clerical Agreement and 111.5(a) of the Physical Agreement. Back pay will be less any outside earnings.

The Committee further agreed that, should the Company receive further wage garnishments for the grievants between the date of reinstatement and the date they receive their retroactive paychecks, no disciplinary action will be taken.

P-RC Case No. 789 concerns a three-day disciplinary layoff. This case is settled without adjustment.

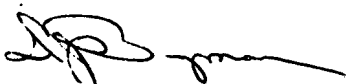

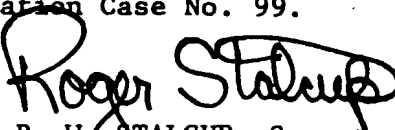
