The above-subject grievances have been discussed by the Pre-Review Committee prior to their docketing on the agenda of the Review Committee and are being returned, pursuant to Step Five A(v) of the grievance procedure, to the Local Investigating Committee for settlement in accordance with the following:

Subject of the Grievance

These cases concern the appropriateness of upgrading employees to the Underground Installer and Utility Underground Installer classifications on a day-to-day basis.

Discussion

In both of these Pre-Review cases, the grievants were upgraded to the Underground Installer and Utility Underground Installer classifications on an as-needed basis. It was the position of the Company that this was a proper utilization of this classification in accordance with Section 205.3. The Union opined that in negotiating these two classifications, the Company committed to upgrading the senior qualified prebidder on a continuous basis.

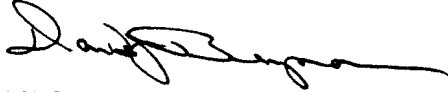
Decision

The Committee recognizes that the parties are currently discussing various matters in dispute involving the underground installation crews. However, current agreement does exist that upgrades into Underground Installer and Utility Underground Installer classifications should be accomplished on a payroll change tag; i.e., for a minimum of 21 consecutive days. Therefore, as a non-prejudicial settlement in these two cases, the Committee agrees that the upgrade of the grievants should have been in increments of at least 21 consecutive days, beginning 30 days prior to the filing of each grievance. The

issue of back pay liability is referred back to the Local Investigating Committee for resolution based on the above, and the Pre-Review Committee retains jurisdiction if the Local Investigating Committee is unable to resolve that issue.

Based on the above, these cases are considered closed.
